SUMMARY ANNUAL REPORT

FOR COOK GROUP HEALTH PLAN

This is a summary of the annual report of the COOK GROUP INCORPORATED – COOK GROUP HEALTH PLAN, EIN 35-1084188, Plan No. 501, for the period January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Cook Group Incorporated has committed itself to pay certain medical, dental and vision claims as incurred under the terms of the plan.

Insurance Information

The plan has a contract with SUN LIFE ASSURANCE COMPANY OF CANADA to pay certain claims incurred under the terms of the plan that exceed certain pre-established limits. The total premiums paid for the plan year ending December 31, 2022 were \$4,011,231.

Basic Financial Statement

Benefits under the plan are provided through the above noted insurance policy and a tax-exempt trust fund that holds this plan's assets.

The value of plan assets, after subtracting liabilities of the plan, was \$333,047 as of December 31, 2022, compared to (\$5,894,090) as of January 1, 2022. During the plan year the plan experienced an increase in its net assets of \$6,227,137. The plan had total income of \$123,361,194 including, employer contributions of \$99,092,128, participant contributions of \$17,281,256, earnings from investments of \$1,185, and other income from refunds and rebates of \$6,986,625.

Plan expenses were \$117,134,057. These expenses include \$107,831,175 in benefits paid to participants and beneficiaries, \$4,011,232 to insurance carries for the provision of benefits, and \$5,291,650 in administrative expenses.
